

INFRASTRUCTURE CHARGES REGISTER

This Infrastructure Charges Register has been prepared in accordance with Schedules 22 and 24 of the *Planning Regulation 2017* under the *Planning Act 2016*.

Former Statutory Policy S0039 - Adopted Infrastructure Charges (former Charters Towers City Planning Area)

This Infrastructure Charges Register includes all Development Permits where a levied infrastructure charge has been issued since the commencement of *Statutory Policy S0039 - Adopted Infrastructure Charges (former Charters Towers City Planning Area)* on 10 August 2011.

For calculating the levied infrastructure charge under S0039, 1 x W = water, 1 x S = sewer, 1 x T = transport, 1 x SW = stormwater and 1 x P = parks. Each unit equates to \$2,000.

On 20 March 2019 at Council's General Meeting Council resolved to (R2856);

- 1) Close all outstanding accounts in relation to the payment of a levied charge issued against development permits lodged and approved post 10 August 2011 under *Statutory Policy S0039 – Adopted Infrastructure Charges (former Charters Towers City Planning Area)*; and
- 2) Notify all affected land owners of this decision via formal correspondence.

Correspondence was sent on 26 March 2019 (ECM No. 1250342) to those landowners whom were affected by the resolution. Those whom were affected by this are noted within this register.

Statutory Policy S0039 - Adopted Infrastructure Charges (former Charters Towers City Planning Area) was revoked at Council's General Meeting held on 29 January 2020 (R3181).

Former Infrastructure Charges Resolution (No. 2) 2020

This Infrastructure Charges Register includes all Development Permits where a levied infrastructure charge has been issued since the commencement of *Infrastructure Charges Resolution (No. 2) 2020* on 10 February 2020. *Infrastructure Charges Resolution (No. 2) 2020* was approved at Council's General Meeting held on 29 January 2020 (R3181). Please note that the *Infrastructure Charges Resolution (No. 2) 2020* did not include an automatic increase provision.

Current Infrastructure Charges Resolution (No. 3) 2020

This Infrastructure Charges Register includes all Development Permits where a levied infrastructure charge has been issued since the commencement of *Infrastructure Charges Resolution (No. 3) 2020* on 28 October 2020. *Infrastructure Charges Resolution (No. 3) 2020* was approved at Council's General Meeting held on 28 October January 2020 (R3446). Please note that the *Infrastructure Charges Resolution (No. 3) 2020* did not include an automatic increase provision.
